WHEREAS, Releasor desires to ride in a Sioux City Police Squad Car; and

WHEREAS, Releasor hereby acknowledges that he/she is on notice that the passenger side air bag in the vehicle in which he/she will be riding has been disengaged for safety reasons in connection with the installation of the Mobile Data Computer (MDC) units in the police squad cars.

## NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

In consideration of being permitted to ride in a Sioux City Police Squad Car while on actual patrol duty, Releasor, for himself or herself, his or her spouse and children, legal representatives, heirs and assigns, hereby releases, waives and discharges the City of Sioux City, Iowa, its elected officials, officers and employees and each of them, referred to as Releasees, from all liabilities to the Releasor, his or her spouse and children, legal representatives, heirs and assigns for any and all loss or damage, and any claim or damages resulting therefrom, on account of injury to Releasor's person or property, even injury resulting in death of Releasor, and/or illness, including but not limited to, any illness or complications associated with the COVID-19 pandemic, whether caused by the negligence of Releasees or otherwise while riding in a Sioux City Squad Car on patrol duty or for any purpose while associating with the Sioux City Police Department in this activity.

Releasor agrees to indemnify the Releasees and each of them from any loss, liability, damage or cost they may incur due to the activity contemplated herein whether caused by the negligence of the Releasees or otherwise.

Releasor hereby assumes full responsibility for the risk of bodily injury, illness, death or property damage due to the negligence of Releasees or otherwise while in or upon the Sioux City Police Squad Car or nearby while actually participating in this activity.

Releasor, as consideration for being permitted to participate in this activity, hereby releases Releasees from any claim for damage to any personal property owned by Releasor used in this activity whether caused by the negligence of Releasees or otherwise.

Releasor agrees to indemnify and hold harmless the Releasees from and against all loss, all risk of loss and all damage (including expense) sustained or incurred because of or by reason of any and all claims, demands, suits, actions, judgments and executions for damages of any and every kind and by whomever and whenever made or obtained, allegedly caused by, arising out of or relating in any manner to the activity contemplated herein and to protect and defend Releasees, and any of them, with respect thereto. Releasor waives on behalf of itself and its insurer any subrogation claim for workers' compensation payments made to any employee arising out of the activity contemplated herein.

Releasor further acknowledges that in case of a police emergency that he/she may be asked to exit the patrol car and may be left in an area deemed to be a safe location in the opinion of the assigned officer to ensure the releasor's safety while the assigned officer responds to an emergency that in the opinion of the assigned officer may pose an unreasonable risk to the safety of the releasor, including but not limited to response to officer in need of assistance response, public disturbance and/or shots fired responses.

Releasor expressly agrees that this release and waiver is intended to be as broad and inclusive as permitted by the laws of the State of Iowa, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
